Pedro A. García Bilbao (Vigo, Spain, 1961). Sociologist. Doctor in Political Science and Sociology (UPSA-Universidad Pontificia de Salamanca). Associate Professor (Universidad Rey Juan Carlos URJC), a specialist in Change and social conflict and political sociology. He did his doctoral thesis on forced migration and exile processes. Diploma in European Communities (Diplomatic School). He is chairman of the *Research Committee on Sociology of Communication and Language* of the *Spanish Federation of Sociology* (FES), is principal investigator in «Cátedra China» —'sociology of Chinese society— and member of the *Chair of Studies on Security and Defence "Francisco Villamartín"* (URJC-CESEDEN). He is a professor and has directed Master thesis in postgraduate studies in the URJC many Chinese students in research and management of business communication, including students from the region of Tibet. He is an analyst of international politics at the russian international television channel RT for spanish speaking countries.

He is the founder of *Critical Sociology / Sociología Crítica* blog, dedicated to international political and social issues, including the reality of China. In 2009 he published a report on resource scarcity and African policies in the context of a larger study on Africa as the scene of confrontation between the great powers published by the Center for Studies of National Defense (CESEDEN), which analyzed the activity China on the African continent (Africa, new scenario of confrontation?, CESEDEN, 2011), in his study professor García Bilbao stated that China was a need to seek new allies in other continents where to get resources because of foreign pressure its eastern borders. About Tibet has published the article, «*Development, high mountains and high politics: the case of Tibet. A look from sociology*», at the blog *Sociología Crítica* [URL: <http://wp.me/pF2pW-3Pe>]. Currently, dr. García Bilbao is coordinator of a research (Cátedra China) on the current Chinese response to political and social problems.

He is a member of the *International Sociological Association* (ISA-AIS), the *Spanish Federation of Sociology* (FES) of the *Asociación Castellano Manchega de Sociología* (ACMS) and the *Spanish Association of Military History* (ASEHISMI). He has made teaching stays or research at the Pontifical Catholic University of Rio de Janeiro (Brazil) and the University of Évora (Portugal) and numerous academic activities in many universities and Spanish and foreign institutions (Academy of Sciences of the Russian Federation State University of Social Sciences of Russia, Russian Institute for Strategic Studies, University of Oxford, University of Limoges and others). He is also president of the *Forum for Memory of Guadalajara* and founder of *Collective Serving the Republic*. He has worked as a sociologist in the Foreign Service Spanish Red Cross (Madrid) and in its central office. He did his doctoral thesis on "Sociology of migration" (UPSA- 2005). He has published *De la Rusia eterna a la Rusia real* (2009), *Franco's repression in Guadalajara* (2010), *Forced Migration: Analysis of a concept*, (2011), *Duxford, memory, military museums and democratic identity* (2012), *Ukraine: between the Maidan and Novorossia. Analysis and texts on the war in the Donbass* (2015) as well as contributions to collective works, academic papers and participation in conferences and seminars. He won the Short Story Award of the Polytechnic University of Catalunya 1999 (Mention UPC) for his work "Fuego sobre San Juan". A member of the *Ateneo Científico, Literario y Artístico de Madrid* since 1984 (No. 21,300); He has been president of the Latin American Section and Social Sciences at present; He was a member of the Governing Board as a Second Vocal between 2011 and 2014.
